FORMER AMBASSADOR HEYMAN TO OFFER INSIGHT INTO UPCOMING U.S. ELECTION AT 2025 ECONOMIC OUTLOOK

(Calgary, Alta.) – Former United States Ambassador to Canada, Bruce Heyman, will appear as the keynote speaker at Calgary Economic Development's upcoming <u>2025 Economic Outlook</u> on Oct. 8 to share insights on how the U.S. election will impact Calgary and Alberta's economy in 2025.

Analysts have been speculating for months about how the election results could impact <u>trade</u> <u>policies and tariffs</u>, <u>energy</u> and <u>tech sector</u> development for Albertan and Canadian businesses in the coming year. This year's event, taking place one month before Americans head to the polls in a close election, will evaluate the uncertainty and how to navigate it.

"As a convener of important conversations for our community, we are excited to have Bruce Heyman join us as the keynote speaker for this year's Economic Outlook event," said Brad Parry, President and CEO of Calgary Economic Development (CED). "With his deep understanding of the economic ties between our two countries, he will share how the U.S. election outcome will impact the future of Canada's economy more than ever before as our bilateral relationship with Canada's number one trading partner evolves."

Heyman, a former partner at Goldman Sachs, served as the U.S. Ambassador to Canada from 2014 to 2017, where he was a key player in strengthening bilateral relations. In 2019, he was appointed co-chairman of the Advisory Board to the Canada Institute at the Wilson Center and published *The Art of Diplomacy: Strengthening the Canada-U.S. Relationship in Times of Uncertainty* with his wife, Vicki.

In recent interviews with <u>CTV News</u>, <u>BNN Bloomberg</u> and <u>CBC</u>, the former ambassador shared his initial thoughts on the potential impact the American election results could have for Canada's economy.

2025 Economic Outlook, powered by ATB Financial, will also explore how Alberta businesses can navigate macroeconomic trends and plan for multiple scenarios in 2025 with a keynote from Mark Parsons, Vice President and Chief Economist, ATB Financial.
